Some interesting things in the Grand Lodge (GL) Statues dealing with new Applications for Membership. In Section 14, an application for membership may be withdrawn by the proposer in open Lodge at any time prior to balloting on that individual. However, in another Section of 14, it states: after a favorable ballot on an application for membership and before initiation, if a member declares in open Lodge that a candidate is unworthy to be a member stating grounds to support such declaration and they appear true a new ballot will be considered on this application by a motion made on the floor of the Lodge. If a 2/3 vote cast is favorable, the election shall stand confirmed.

You will also notice that the monthly bulletins will start showing these new applications. If any member knows a reason for rejecting an application, they should come to the meeting and state so.





I'm not sure if you've noticed, but we had Cal Trans clear all the overgrown brush in front of the Sound Wall on the West side of our Lodge. Not only was it a Fire Hazard, but it blocked our beautiful mural. Today, 6-10-22, we had the "out of operation for 10 months" #2 HVAC unit repaired.

I'm pleased to report the Lodge is very comfortable inside. I'm sure I have missed some stuff, but you can get an idea of how busy we've been.

- Our near future projects will include:
 - Replacing the gutters and downspouts on the front of the Lodge.
 - Painting the entire Lodge.
 - Probably trimming some trees.

If you members see something outside the Lodge that needs attention, contact me or any of our Board Members. The ABHC, Inc. office is in the foyer next to the shuffleboard room. We will soon have a mail drop installed on the door to receive any communications.

Kitchen, lights, loose screws, broken or needing to be replaced equipment, and sometimes outside vegetation trimming and blowing.
