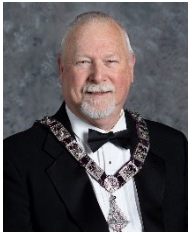

GL Statues 12.050 deals with the duties of the Secretary of the Lodge. While there are many duties listed, there are also opinions and decisions listed as well. A couple of the opinions of interest that some wonder about are: #5 Both the Secretary and Exalted Ruler have the right to collect mail, but the Exalted Ruler cannot demand a key to the Secretary's office nor the combination to the safe nor password to the Secretary's computer, which has all the membership records. #6 While the Secretary may collect all mail for the Lodge, any mail addressed by name to the Exalted Ruler or other person of the Lodge should be delivered to them unopened unless each has given the Secretary permission to open. Lodge mail not bearing a name can be opened by the Secretary as the Lodge's correspondent. #8 All Lodge records should be open for inspection by a member at all reasonable times. #15 If the office of the Lodge Secretary is vacant, necessary continuity in the signing of issuance of membership cards and other Secretarial duties should be exercised by an Acting Secretary appointed with full power and authority by the Exalted Ruler until an election can be held. (side note: I'm not leaving as Secretary).

INFORMATION REGARDING A RESOLUTION TO BE SUBMITTED FOR VOTE AT A REGULAR LODGE MEETING ON 22ND DAY OF SEPTEMBER THAT THE LODGE MERGE WITH GRASS VALLEY. (resolution details follow)



Auburn Elks Lodge # 1691

August 8, 2022

Dear Member,

At a regular Lodge meeting on the 22nd day of September, of 2022, a resolution will be submitted by the Board of Trustees of Auburn, No. 1691 for a vote that the Lodge merge with Grass Valley, No. 538 and shall be known as Auburn/Grass Valley, No. 538.

The decision to consider merging of the Lodges was not made in haste. Your Lodge Officers and Trustees have discussed the possibility of a merger for quite a while. We honestly believe this is the best interest of our Lodge.

By merging, we feel that we can better promote the programs and charities of our Lodge and the Order. Also, we will have a larger group of members to choose from for our Officer corps and Committee persons.

Please attend the Lodge meeting September 22, 2022, for a vote on this most important matter.

Thanks for your time and consideration.





1. Grass Valley Lodge, No. 538 of the Benevolent Protective Order of Elks of the United States of America ("Grass Valley Lodge") shall merge with the Auburn Lodge No. 1691 of the Benevolent Protective Order of Elks of the United States of America ("Auburn Lodge").
2. The surviving entity shall be the Auburn/Grass Valley Lodge.
3. The new Lodge name shall be changed to Auburn/Grass Valley Lodge No. 538 of the Benevolent Protective Order of Elks of the United States of America.
4. The Lodge # will be 538.
5. The Merged entity will have a new charter.
 - a. The Charter will be changed to reflect the name of the new Lodge.
6. The effective merger date will be voted on upon approval of Merger Committee.
7. Upon completion of the merger, the merged entity shall undertake a bylaws revision via a committee comprised of members from both Lodges.
8. Current Lodge officers of Grass Valley and Auburn will continue to serve in their respective positions until the merger is completed, after which elections for officers will be held for the merged entity via the combined membership.
 - a. Nominations within 30 days of the merger.
 - b. Elections to follow per the statutes – 30 days minimum from nominations.
9. The newly elected Trustees of the merged entity shall not list the real estate holdings of Grass Valley or Auburn Lodges for sale.
 - a. It is not the intention to sell the real estate holdings; however, circumstances may arise that require a Trustee's decision to bring a vote to the floor of the Lodge for the sale of said property.
10. The existing lodge building for the current Auburn lodge shall be the lodge building on record for the merged Lodge. Grass Valley Secretary and Treasurer records shall be moved to the Auburn Lodge.
11. The existing lodge building for the current Grass Valley lodge shall be transferred as an investment property under the Auburn Building Hall Company, Inc., and can be used as an event center.
12. All active members of both Lodges shall retain their current membership numbers unless it is discovered through CLMS that duplicate numbers exist. If this occurs, the member with the highest seniority retains the original number.
13. All current Life and Honorary Life Memberships from both Lodges will continue and be recognized by the merged Lodge entity.
 - a. Any member who is eligible for life membership for their respective Lodge shall retain their existing years and not lose the opportunity to become a Life Member under the merged entity.
14. The respected Lodge memorabilia shall remain in the current Lodge it is located.
15. The Lodge business and membership records and files from both Lodges shall be provided to the Auburn Lodge location for reference and safekeeping.
16. Membership dues following the merger will be based on new bylaws.
17. Past Elks of the Year, Officers of the Year, and Past Exalted Rulers shall maintain their status and be recognized by the merged Lodge entity.
18. Lodge property from the respective Lodges that are not useable or determined to be surplus will be identified and stored for future disposition Inventories to be kept at the Lodge office, sales proceeds shall be deposited into the general fund.

19. A business plan for the merged Lodge entity shall be prepared by the Merger Committee and submitted to the Trustees and House Committee of the merged entity for discussion, input, and acceptance, as soon as possible after the effective merger date.
20. A budget for the merged Lodge entity shall be prepared by the Merger Committee and submitted to the Trustees and House Committee of the merged entity for discussion, input, and acceptance, as soon as possible after the effective merger date.
21. Regularly scheduled Lodge meetings will occur in the current Auburn location.
 - a. Regularly scheduled House Committee and Trustee meetings will be held at locations to be decided by their respective committees.
22. The merged entities Lodge Secretary and Treasurer operations will be moved to the Auburn Lodge location.
23. Each Lodges respective Event operations shall remain in their current Lodge. The ABHC, Inc. will take over the events at the Grass Valley location.
 - a. Both Event Coordinator's will report to the merged entities House Committee.
24. Grass Valley Lodges apartments operations will be brought under the Auburn Building Hall Company, Inc. The Entire Grass Valley location will be under the control of ABHC, Inc.
25. The merged entity shall retain the existing ABC license for the Auburn Lodge only. The Lodge can only have one license, events at Grass Valley will need a permit.
26. The exterior maintenance and repair of both Lodge buildings shall fall under the merged entity Auburn Building Hall Company, Inc.
27. Existing contracts for interior cleaning and exterior landscaping and gardening services shall be retained pending a review of the merged entities Trustees, and under the direction of the ABHC, Inc.
28. Banking services/Investment accounts for the merged entity shall be reviewed after the merger by the Trustees.

NOW, THEREFORE, BE IT RESOLVED, That the Board of Trustees of Auburn Elks Lodge, Number 1691 recommends that the Lodge merge with Grass Valley Elks Lodge, Number 538, and shall be known as the Auburn/Grass Valley Elks Lodge Number 538.

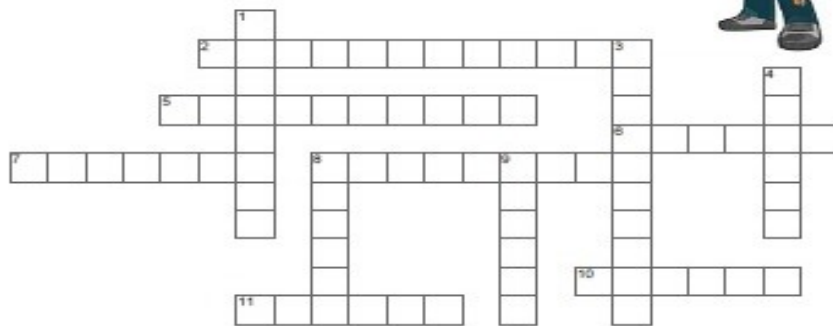
